

## Instruction for use

## **Operation method:**

- 1. Open the lancet protection cap:
- 2. Place the lancet in Lancing device
- 3. Launch the lancing device
- 4, Remove the lancets from lancing device and dispose

#### **Announcements:**

- 1. Use the lancet as soon as it is unpacked.
- 2. The lancet is single-use, after usage it must be destroyed by burning or according to the ground of hospital to handle.

# Storage:

- 1. Avoid exposure to high temperature, high humidity, direct sunlight and water
- 2. Avoid scars and pinholes on the packing material.
- 3. Check the expiration date on the product. Discard if it is overdue. Also discard Lancets left unused longafter they are unpacked

#### **Expiration Date:**

This product may be used up to 5 years after date of production, as indicated on the package label, so long as it is maintained in accordance with an appropriate storage procedure.
